## Meeting Minutes

Date: 9 January 2012

1. The meeting was called to order by President Blair Peterson at 6:01 PM. Four ( 4 ) officers, thirty nine ( 39 ) members and four ( 4 ) guests attended this meeting.
2. The Treasurer ( John Ferris ) was unable to attend this meeting, however, John had forwarded his Report to the officers, which was read to the members. The November balances are as follows.
  - Last month's balance was \$3,426.53
  - This month's balance is \$2,291.54 after adjustments for income ( \$110.00 ) and expenses ( \$1,244.99 )

- The next Tournament that the Club will host after the NFAA Indoor Round will be an International Round on Sunday, 5 February. Because this Tournament will take place before the next Club meeting, a “work party” at the range is scheduled for Thursday, 2 February at 9:00 AM.

Norm Lewis volunteered to run the line for this Tournament. Mary Ann Hartman, Jim McCauley and Kathy Van Ostran volunteered to handle the registration duties. Thanks to everyone who volunteered to make this Tournament a success.

- Jeff Wiseman was asked to speak about the Club’s Winter Handicap League competition which will start on Monday, 16 January.

Jeff reported that there will be 12 weeks of competition and that twenty four ( 24 ) people had signed up ( 6 teams of 4 each ). Weekly matches are to take place on Monday, unless otherwise scheduled by the individual competitors, and are to be completed by Saturday evening.

This year a “verified” round has been introduced to permit individuals to complete their matches in the absence of their scheduled “opponent”. Verified rounds have to be shot with two ( 2 ) other League members present. Weekly results will be distributed by e-mail ( to the League members ), posted on the Bulletin Board at the range and published on the Club’s website.

- At last month’s meeting the Club approved the purchase of a number of items. Their status is as follows.
  - ~ The “EZ Press” bow press that Ken Woolley demonstrated has been purchased from Ken and is now installed in the Field House workroom. Thanks Ken !
  - ~ A chronograph and grain scale has been purchased from Lancaster Archery. They are in the locked cabinet in the Field House workroom
  - ~ Norm Lewis has donated his homemade spline tester that he demonstrated to the Club at the end of the meeting. It has been installed on the workbench in the Field House workroom. Thanks Norm !
